00:01:32	Dr. Billy Hensley	During 2021, in partnership with the Council for Economic Education, we hosted a series of policy convenings, taking a deep dive into some of the most pertinent issues the financial education field faces.
00:01:46	Dr. Billy Hensley	We invited advocates from around the country to share what they see every day in their states and local communities.
00:01:51	Dr. Billy Hensley	We listened. We learned.
00:01:54	Dr. Billy Hensley	We heard about the successes and shortcomings from more than 250 experts, representing 44 states.
00:02:01	Dr. Billy Hensley	We discussed the issues behind post-secondary education, alternatives to financial education mandates, evidence-based financial education programming, financial education in rural communities, and how financial education can better support diverse cultures.
